Date: May 16, 2018

RECOMMENDATION:

Approve grant allocations **OPTION “C”** as shown on attached ranked list spreadsheet.

BACKGROUND:

Thirty-two applications were received this year. Three were determined by staff to be ineligible. The remaining 29 were reviewed by two panels: 10 applications for Organizational Support were reviewed on May 4 and 19 applications for Project/Program Support on May 7. Each application was discussed, and samples of artwork submitted with the applications were viewed.

Applications were scored individually by each panelist. (Brief panelist bios follow this memo.)

These scores were averaged, and each application was assigned a score, thus creating a rank order list.

DISCUSSION:

The request amount of all eligible applications was \$214,802. Staff reconciled budget figures with County Accounting Department and then projected anticipated expenses to year end. An estimated \$82,423 is available for funding of Local Arts Grants (revised budget spread sheet is attached.) In the past the Commission has adhered to an unwritten policy that no organization be funded at less than 50% of their request amount.

The attached Rank List spreadsheet shows three options for funding:

- Option “A” which is a best-case scenario shows 100% funding for the top-ranking applicants and 10% decreases by rank through the fundable applications.
- Option “B” shows a decreased amount of 90% at the top rank, also decreasing by 10% at each rank but having a higher cut -off to get closer to the estimated available funds.
- Option “C” reorganizes the applicants into just three divisions of 85%, 75% and 50% and is within \$1,352 of estimated available funds.

FISCAL IMPACT:

There will be no fiscal impact.
